

Regulations and tariffs for the reproduction rights of the documents housed in the Doria Pamphilj Archives (hereafter referred to as "the Documents")

Art. 1. General Rules.

1. Photographs or other images of the Documents are protected by copyright laws and their creators, owners or concession holders, as copyright holders, have the absolute right to control how they are used. Those who infringe copyright can be subject to economic sanctions, destruction of reproductions and criminal penalties.

2. The reproduction of the Documents must be carried out in compliance with the nature of a private service of social utility, as attributed to privately-owned exhibition facilities by article 101, paragraph 4, of the Italian Code for Cultural Heritage, and with the purposes of social solidarity indicated in article 111, paragraph 4, of the said Code regarding the enhancement of privately-owned cultural property.

3. Reproduction rights for the Documents must be granted in writing, in compliance with the rules established by these Regulations and by articles 126 paragraph 3 (concerning the processing of personal data) and 127 of the Code for cultural heritage. These rights can vary according to:

- the type and duration of use;
- the means and methods used to carry out the reproductions;
- the use and purposes of the reproductions, also in regards to how they are distributed and transmitted;
- anything else the Doria Pamphilj Administration company (ADP), who is responsible for the management of the Archives, deems appropriate and/or necessary for the conservation and enhancement of the Documents themselves.

4. In any case, it is forbidden for authorised individuals to have direct access to a Document; a Document can only be used with the assistance of a staff member employed in the Archives.

Art. 2. Study and personal consultation use.

For the reproduction of Documents for study and personal consultation purposes, the following fee must be paid in advance:

- €0.50 not including VAT for a single b/w photocopy exclusively for A4 sized prints in good condition and dated after 1900;
- €0.75 not including VAT for a single b/w photocopy exclusively for A3 format prints in good condition and dated after 1900.

(in addition to the price of each single photocopy, there is a fixed rate of € 5 for each item in the archives: volume, envelope, file, etc.);

- €2.50 not including VAT for a single digital scan jpeg jpg/300dpi in colour of originals not larger than 22x32 cm dated before 1870, and in good condition
(in addition to the price of the single shot, there is a fixed rate of €10 for each item in the archives: volume, envelope, file, etc.);
- €5 not including VAT per single digital scan jpeg jpg/300dpi in colour of originals larger than 22x32 cm and up to 29x42 cm dated before 1870, and in good condition.
(in addition to the price of the single shot there is a fixed rate of €10 for each item in the archives: volume, envelope, file, etc.);
- price to be agreed per single digital jpeg jpg/300dpi colour scan of originals larger than 29x42 cm dated before 1870, and in good condition *(in addition to the price of the single shot there is a fixed rate of €10 for each unit in the archives: volume, envelope, file, etc.);*
- €5 not including VAT for any transfer of images to CD-ROM format.

Art. 3 - Scholarly publications: E-Prints, Working papers, Paper-Reviews, Preprints and Doctoral Theses.

1. The meaning of scientific publication is a paper on a scientific topic distributed in paper or digital format by non-profit publishing groups, scientific journals or other publishers, specialized in a maximum of 500 paper copies.
2. Reproduction rates that apply to this kind of use are the same as in the article above and must always be paid in advance; however, publication must be explicitly authorized by the ADP company who can grant a non-exclusive publication right for the duration and distribution as set forth and indicated on the invoice. The requestor commits to inform the ADP of any reprint exceeding the first edition.
3. Any reuse or additional use of ADP images must be requested first in writing and in a format authorized by ADP who will then send a specific invoice. Any reuse of images in an updated edition, or in a different document, must be requested first in writing and in a format authorized by ADP, who will then send a specific invoice.
4. The credit must always bear the following copyright wording: "Doria Pamphilj Archive © ADP s.r.l. " and the "Doria Pamphilj Trust" (with graphics and logo provided by ADP) must be clearly indicated as owner of the Document.

Art. 4 - Printed commercial publications (exhibition catalogs, newspaper or magazine articles, publications) or CD-ROMs, DVDs, E-Books, websites.

For the reproduction of Documents for editorial purposes of a commercial nature, the following fees must be paid in advance:

- €5 not including VAT for one single digital scan jpeg jpg/300dpi in colour of originals no larger than 22x32 cm, dated before 1870, and in good condition, for a single edition of maximum 2,000 copies in one language with distribution in one country only *(in addition to the price of the single shot, there is a fixed rate of €20 for each archive item: volume, envelope, file, etc.);*
- €10 not including VAT per single digital scan jpeg jpg/300dpi in colour of originals larger than 22x32 cm and up to 29x42 cm, dated before 1870, and in good condition, for a single edition of maximum 2,000 copies in one language with distribution in one

single country (*in addition to the price of the single shot, there is a fixed rate of €20 for each archive item: volume, envelope, file, etc.*);

- price to be agreed for a single digital jpeg jpg/300dpi colour scan of originals larger than 29x42 cm, dated before 1870, and in good condition, for a single edition of up to 2,000 copies in one single language with distribution in one country (*in addition to the price of the single shot, there is a fixed rate of €20 for each archive item: volume, envelope, file, etc.*).

2. The credit must always bear the following copyright wording: "Doria Pamphilj Archive © ADP s.r.l." and the "Doria Pamphilj Trust" (with graphics and logo provided by ADP) must be clearly designated as owner of the Document.

3. For printed editions, the ADP can grant non-exclusive publication rights for the duration and distribution set forth and indicated on the invoice. The requestor commits to inform the ADP of any reprint exceeding the first edition. In this case, during the license validity, the ADP will grant a 50% discount on the rights initially paid per image. Any reuse or additional use of ADP images must be requested first in writing and in a format authorized by the ADP, who will then send a specific invoice.

4. Any reuse of images and/or details of documents in an updated edition or in a different document, must be requested first in writing and in a format authorized by the ADP, who will then send a specific invoice.

5. Regarding the use of the images on CD-ROMs, DVDs, E-Books or websites, the ADP can grant the non-exclusive right to reproduce its images only once in a single electronic product in a size that should not be greater than 640x480 pixels at 72dpi, unless otherwise specified in writing by ADP to the requestor.

6. CD-ROMs, DVDs and E-Books must bear the following copyright wording on the disc container, on the first page of the documentation and in the opening titles: "Archivio Doria Pamphilj © ADP s.r.l." and must be clearly designated as owner of the Document the "Doria Pamphilj Trust" (with graphics and logo provided by ADP), with the following statement: "This multimedia product and its contents are protected by copyright. The following actions are prohibited by law: viewing or screening images in public, including broadcasting on the television network; designing or creating similar items that allow the entire or partial extraction of the images".

7. On the web page, the credit must bear the following copyright wording: "Doria Pamphilj Archive © ADP s.r.l." and the "Doria Pamphilj Trust" (with graphics and logos provided by the ADP) must be clearly designated as owner of the Document, with the following wording: "These copyright images are for reference only. It is forbidden by the law to download, reproduce, publish or distribute any image that appears on this site".

Art. 5 - The Musical Archive

1. Study and reproduction of documents that belong to the Musical Archive of the Doria Pamphilj Archives, that are rare manuscripts and prints, is disciplined by specific regulations that prohibit the total reproduction of the items, using any means or methods, execution, recording and broadcasting of partial or entire melodies.

Art. 6 - Final rules.

1. The delivery of files or any other means of reproduction of images does not imply the transfer of rights, and the requestor acts as custodian for the purposes intended. The reproduction rights, which are not exclusive, are limited to one copy (in colour and/or black and white), for a limited duration. Further or subsequent use of each single copy is prohibited unless there is prior written consent from the ADP.
2. The duration of the granted rights varies according to the procedures set forth in a written agreement between the parties and by the abovementioned regulations.
3. In no case can a requestor duplicate the images in his possession without prior written consent from ADP, nor can he/she lend them, rent them, sell them, disseminate them online, on the Internet or on multimedia platforms, sublease them or otherwise transfer them, grant them, or grant licenses to third parties in any way and by any software for reproduction, even if it is for co-editions or free of charge: failure to do so will entail that the contract will be considered *ipso iure* terminated and the requestor will be required to pay damages as well as a penalty of €5,000.00 not including VAT and ancillary rights. Compensation for damages does not confer any rights to the requestor on the images used without written consent pursuant to the law and to these regulations.
4. The unauthorized use of Document images, obtained from the ADP files, illegally scanned from publications, or in any other way acquired or manipulated, will be fined € 5,000.00 not including VAT and ancillary rights.
